### SO2 PADS RECEIVE SECTION 3 REGISTRATION

The California Blueberry Commission (CBC) has received confirmation from the California Department of Pesticide Regulation (CDPR) that the use of Sulfur Dioxide (SO2) Pads is now approved for domestic and export use. Since December 2020, the CBC has annually applied for and received a Section 24C Special Local Needs label to utilize SO2 pads on blueberries for export use only from California. Since that time, the IR-4 Project, USDA-ARS, and CBC have continued to work together to gain data to support an established SO2 tolerance to support registration for full use. On November 17, 2022, the Environmental Protection Agency (EPA), issued a final rule establishing a tolerance on blueberries for total sulfites, a key residue associated with sulfur dioxide application. With the newly established tolerance for SO2, both the EPA and CDPR have approved SO2 pads for use in domestic and export markets through a Section 3 registration. ### INITIAL 2023 WATER SUPPLY ALLOCATIONS FOR CENTRAL VALLEY PROJECT

The Bureau of Reclamation announced initial 2023 water supply allocations for Central Valley Project (CVP) water users. Water supply allocations are based on an estimate of water available for delivery to CVP water users and reflect current reservoir storage, precipitation, and snowpack in the Sierra Nevada. ### RECIPIE CORNER: CALIFORNIA BLUEBERRY AND BANANA MAPLE OATS

### **Ingredients:**

- 1 cup nut butter
- 1/4 cup coconut oil
- 1/3 cup maple syrup
- 1 teaspoon vanilla extract
- 1 large egg
- 1 cup milk
- 3 ripe bananas, mashed

- 3 1/2 cups old fashioned oats
- 1 teaspoon baking powder
- 2 3 scoops protein powder
- 1/2 teaspoon Simply Organic cinnamon
- Pinch of salt
- 1 cup fresh or frozen blueberries

#### **Directions:**

- Preheat the oven to 350°F and grease a 8" x 8" pan with cooking spray.
- Combine the nut butter and coconut oil in a microwave safe bowl. Microwave for 20-30 seconds or until the oil and nut butter are melted. Stir well.
- Mix in the maple syrup, vanilla extract, egg, and milk. Next, add in the mashed banana. Stir in the dry ingredients, including the oats, baking powder, protein powder, cinnamon, and salt. Fold in the blueberries.
- Transfer the batter to the prepared pan and bake for 25-30 minutes. Store in the fridge or freezer.
